नई दिल्ली, 7 सितंबर (भाषा)।

दिल्ली उच्च न्यायालय ने कहा है कि पतंग उडा रहा कोई व्यक्ति अपने प्रतिस्पर्धियों की पतंग काटने के उद्देश्य से मांझे के धागे को धारदार बनाने के लिए उसमें बदलाव नहीं कर

अदालत ने धारदार मांझे के चलते लोगों की जान जाने और घायल होने की दुखद घटनाओं के मद्देनजर यह टिप्पणी की। साथ ही, अदालत ने इस बात का जिक्र किया कि दिल्ली सरकार ने मांझे के तौर पर इस्तेमाल के लिए सिर्फ सूत के बने धागे की अनमति दी है, जिस पर शीशा का लेप नहीं चढ़ाया गया हो। उच्च न्यायालय ने यह आदेश पंतग उड़ाने की सामग्री की बिक्री, खरीद और भंडारण करने वालों के एक संघ की याचिका पर सुनवाई करते हुए दिया। याचिका में, 2017 में जारी एक अधिसूचना को चुनौती दी गई थी।

अधिसूचना के मुताबिक, 'पंतग उड़ाने की अनुमित केवल सूत के बने धागे से होगी, जो कोई धारदार चीज/धात/शीशा/गोंद/धागे को मजबत करने वाले पदार्थों से आदि से मुक्त होगा।' पंतग

उड़ाने में इस्तेमाल किये जाने वाले धागे 'सदी और 'माझा' का निर्माण पारंपरिक रूप से छोटे शहरों में सत के धागे से किया जाता है।

न्यायमूर्ति विभू बाखरू और न्यायमूर्ति अमित महाजन की पीठ ने कहा कि जहां तक निर्देश के बारे में याचिकाकर्ता की शिकायत है, यह गोंद और धागे को मजबत करने वाली सामग्री के उपयोग को निषिद्ध करता है और यह मांझे के विनिर्माताओं या डीलर पर लागु नहीं होता, बल्कि यह पतंग उडाने वाले व्यक्ति को निर्देशित है। दिल्ली सरकार ने भी स्पष्ट किया है कि पतंग उड़ाने की अनुमित सिर्फ सूत के बने धागे से होगी, जो धारदार चीज, धातु, शीशा, गोंद, धागे को मजबूत करने वाले पदार्थों आदि से मुक्त होगा।

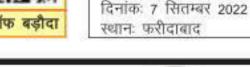

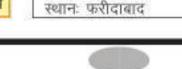
